- 1 These charges are operative from 1.4.2011 to 31.3.2012 and are subject to VAT at the standard rate.
- 2 The above charges are for the hire of East Court Mansion. Regular, weekly and/or monthly hirers will also enjoy the use of the kitchen and bar areas at no extra charge.
- 3 With the exception of the kitchen hire charges shown are per hour and apply for the period from which a booking for any part of the building commences until the event has been booked to conclude or until the building has been vacated, whichever is the later. Hirers must liaise with their own caterers regarding the length of time required for preparation and/or cleaning up.
- 4 All bookings are charged subject to a minimum hiring period of two hours Monday-Friday, six hours on Saturdays and four hours on a Sundays. Periods of less than an hour will be rounded to the hour above.
- 5 The period of use must not exceed time(s) stated in the application. Payment will be required for any extended use in accordance with the scale of charges.
- 6 Food and drink can only be prepared and served from the kitchen and bar area. Where no cooking is to take place in the kitchen hirers are entitled to a 50% reduction in respect of kitchen hire fees and approved charitable groups and organisations will receive a 75% discount.
- 7 Hirers wishing to operate a pay bar are required to make their own arrangements with the licensee Elliott Jones Catering (telephone 01342 719275)
- 8 Under no circumstances must smoke/dry ice effects be deployed on Town Council premises nor may any decorations be affixed to the walls or ceilings.
- 9 East Court Mansion will be closed on Christmas Eve, Christmas Day, Boxing Day and Good Friday. An additional premium charge of £75.00 plus VAT will be charged for bookings on other bank holidays and Easter Sunday, recognising the Council's additional costs in such opening.
- 10 Hirers are responsible for leaving the premises in a generally clean and tidy condition and sufficient cleaning up time must be allowed for this purpose.
