NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to amend parking restrictions on roads in The East Grinstead Controlled Parking Zone as follows:

West Hill: to remove a single yellow line restriction on the northern side of the road and replace it with a restriction prohibiting waiting at any time (double yellow lines)

Fairfield Road: to remove a pay and display parking bay on the western side of the road and replace it with a parking bay for permit holders 9am to 5pm Mon to Sat except bank holidays

Canteloupe Road: to change the restriction on a pay and display parking bay on the eastern side of the road to permit its use by permit holders in addition to pay and display users.

Railway Approach: to remove a parking bay on the southern side of the road and replace it with double yellow lines.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the West Sussex County Council website. The website includes a response form for any comments or objections.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will amend parking restrictions on roads in The East Grinstead Controlled Parking Zone as follows:

West Hill: to remove a single yellow line restriction on the northern side of the road and replace it with a restriction prohibiting waiting at any time (double yellow lines)

Fairfield Road: to remove a pay and display parking bay on the western side of the road and replace it with a parking bay for permit holders 9am to 5pm Mon to Sat except bank holidays

Canteloupe Road: to change the restriction on a pay and display parking bay on the eastern side of the road to permit its use by permit holders in addition to pay and display users.

Railway Approach: to remove a parking bay on the southern side of the road and replace it with double yellow lines.

West Sussex County Council conducts a programme of review of the Controlled Parking Zones in the county. In East Grinstead this has identified concerns about parked vehicles obstructing visibility on West Hill and Railway Approach and that amendments to restrictions in Fairfield Road and Cantelope Road would better serve the type of parking needed in these roads.

The opportunity is also being taken to clarify the plan showing the boundary of the controlled parking zone on Hurst Farm Road and Garden Wood Road so it more clearly shows which addresses are eligible to purchase residents' permits.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to improve the amenities of the area through which the road runs.

The attached drawings, numbered TQ3837NEN, TQ3837NES, TQ3937NEN, TQ3938SES and TQ3938SWS show the lengths of roads affected by the proposed order.
