Notes for applicants:

1. Type of Refreshment Unit

Applicants are asked to provide information on the existing or prosed format and size or retail unit. To include details of:

- a) Dimension of the retail unit
- b) Colour / Branding
- c) External Material i.e. wood panelling / metal
- d) Static trailer or self-propelled van
- e) If applicable type of vehicle engine / Clean air i.e. solar power

Applicants should familiarise themselves with the access and layout of the area and the precise location granted to the mobile unit as approved by EGTC.

2. Equipment

Applicants should detail any equipment that will be used within the mobile unit, including all electrical appliances and furniture.

3. Type of Refreshments

Applicants are asked to give details of the range of refreshments that would be on offer.

Please note No alcohol sales will be permitted.

4. Water & Power

Water – Applicants can access to an external tap to fill water carriers / containers only.

Power – Applicants are asked to provide information on how their unit will be powered

- a) Generator, how the noise of this equipment would be controlled.
- b) Mains Power. Please detail the electric supply needed.
- c) Are gas heaters to be used?

Please note applicants will be charged for their electricity consumption.

5. Required Trading Conditions

Expected times and days of operation. Consideration should be given to seasonal and regular users of East Court.

- a) Number of Days per week
- b) Number of Months per year
- c) Expected number of hours trading daily
- d) Will the retail unit be static or removed from East Court daily before sunset?

Applicants must comply with Food Safety Requirements according to the Foot Hygiene Regulations 2006.

The concession will be given only to an operator who is registered with an appropriate authority as a food business. Please therefore supply details of your registration.

6. Sustainability

Applicants are asked to provide information on the environmental sustainability of their operation. Applicants should include information on use of sustainable/compostable containers, reusable cups, waste minimisation.

7. Waste & Litter Management

The unit operator will be expected to manage and control litter and waste from their trading activity to stop it from adversely affecting the site. Applicants should indicate what waste collection, handling, and disposal they would undertake.

8. Fee Offered for Pitch

Applicants should clearly indicate the level of fee they would offer for the licence to operate their refreshment stand for 12 months.
