


4. Land and Property

Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer




6. Corporate Tenancies

- (b) the tenant is a body that the councillor,



Any beneficial interest in securities* of a body where—


- (a) that body (to the councillor's knowledge) has a place of business or land in the area of the council; and
