The first survey took place between 8th and 31st October.

Town Councillors manned stations at Wickendens, Queens Walk and Sainsburys, talking to passers by and filling in the surveys. Additionally surveys were handed out at the railway station on the morning of 7th October and the online survey has received a steady stream of responses. In total around 1500 surveys were handed out and 640 replies received. The presence of the councillors and the survey was advertised in the local newspaper during the three weeks of the survey and a banner was placed in the town centre. The website also carried the electronic link and a downloadable form for return.

The Survey asked how far certain statements were agreed with on 7 areas that will be expected to feature in the forthcoming plan. These areas were:
